ASSIGNMENT

WHEREAS I, Hiroki KIKUCHI of c/o ROHM CO., LTD., 21, Saiin Mizosaki-Cho, Ukyo-Ku, Kyoto-Shi, Kyoto 615-8585 Japan (hereinafter referred to as "ASSIGNOR") have invented certain new and useful improvements in:

INSULATED SYNCHRONOUS RECTIFICATION DC/DC CONVERTER

which claims priority to Japanese Application No. JP2016-244700, filed December 16, 2016, and for which I am about to file or have filed an application for Letters Patent of the United States;
