Further, ASSIGNOR hereby authorizes and requests the Commissioner of the U.S. Patent and Trademark Office, and any official of any country foreign to the United States whose duty is to issue patents, design registrations, inventors certificates or the like, to issue any and all Letters Patent, registration or certificate for such invention to ASSIGNEE, its successors and assigns, as the owner of all right, title and interest therein.
