PARTIES

- (1) Piush Shashikant Soni of 30 Stoughton Road, Oadby, Leicester, LE2 4FL, United Kingdom. (Assignor).
- (2) NKD Europe Ltd incorporated and registered in England and Wales under company registration no 08410701 whose registered office is at 81 London Road, Leicester LE2 0PF, United Kingdom (Assignee).

BACKGROUND

The Assignor owns all the intellectual property rights in the Materials (as defined below). The Assignor has agreed to assign to the Assignee all the intellectual property rights in the Materials on the terms set out in this agreement.

AGREED TERMS

1. INTERPRETATION

The definitions and rules of interpretation in this clause apply in this agreement.

Assigned Rights: all Intellectual Property Rights owned by the Assignor arising from work done on the Materials which are capable of subsisting, including without limitation the bottle designs and design applications in Schedule A.

Intellectual Property Rights: designs, patents, rights to inventions, copyright and related rights, trade marks, business names and domain names, rights in get-up, goodwill and the right to sue for passing off, rights in designs, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world.

Materials: water filtration technology and water filtration devices and all related accessories including but not limited to the nkd POD, nkd POD+ and nkd LIFE bottles.

Z. ASSIGNMENT

- 2.1 In consideration of the final settlement of all invoices and monies owed to the Assignor (receipt of which the Assignor expressly acknowledges) in respect of the Materials, the Assignor hereby assigns to the Assignee absolutely with full title guarantee all its right, title and interest in and to the Assigned Rights and the right to sue for and recover damages and other remedies in respect of any infringement of or acts of passing off in respect of the Assigned Rights which may have occurred before the date of this agreement.
- 2.2 The Assignor confirms that the assignment in clause 2.1 above includes but is not limited to the US design patent application referenced in Schedule A and to all other patent applications (including divisional, continuation, continuation-in-part, and reissue applications) based upon said design, and in and to the patent or patents to be granted thereon, to the full end of the term or terms for

which said patent or patents may be granted. The Commissioner of Patents and Trademarks of the United States is hereby authorized and requested to issue said patent or patents to Assignee.

3. FURTHER ASSURANCE

- 3.1 The Assignor shall perform (or procure the performance of) all further acts and things, and execute and deliver (or procure the execution or delivery of) all further documents, required by law or which the Assignee requests, to vest in the Assignee the full benefit of the right, title and interest assigned to the Assignee under this agreement.
- 3.2 The Assignor irrevocably appoints the Assignee to be its attorney in its name and on its behalf to execute documents, use the Assignor's name and do all things which are necessary or desirable for the Assignee to obtain for itself or its nominee the full benefit of clause 3.1.

4. MORAL RIGHTS

The Assignor hereby unconditionally and irrevocably waives all moral rights which it has in the Assigned Rights, including but not limited to the rights set out in sections 77 and 80 of the Copyright Designs and Patents Act 1988.

5. ENTIRE AGREEMENT

This Agreement sets out the entire agreement and understanding between the Parties and supersedes any previous agreements between them relating to the subject matter of this Agreement.


6. GOVERNING LAW AND JURISDICTION
