Assignment of Invention

WHEREAS [I/WE], ALLIDIERES Laurent, DEVILLIERS Clémence, FRANCOIS Thibaut and FLYNN Julie, , have invented certain new and useful improvements documented in a patent application entitled "Station and method for filling a tank with a fuel gas" for which a United States patent application was filed on October 10, 2017, having Application No. 15/565,573

Further, [I/WE] agree that [I/WE] will communicate to said ASSIGNEE or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all non-provisional, divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions.

The undersigned hereby grants authorized representatives of the above identified ASSIGNEE the power to insert on this assignment any further identification, INCLUDING ANY SUBSEQUENT DATE OF APPLICATION FILING AND THE APPLICATION SERIAL NUMBER, which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
