- 6) The Effective Date of this Assignment of Patent Application is **October 13, 2016**.



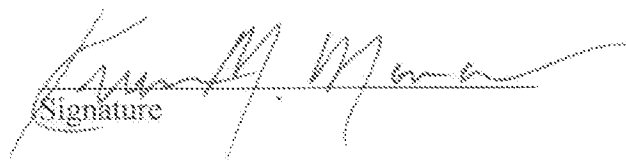

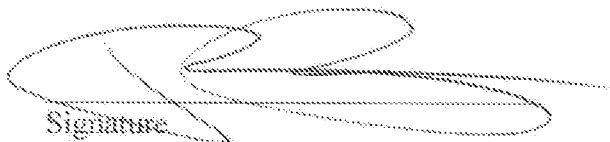
