Release Of Security Interest In Patents

This Release of Security Interest in Patents (this "Release") is made as of November 21, 2017, by ALMC hf., formerly known as Straumur-Burdaras Investment Bank HF, a company incorporated in Iceland ("Security Trustee"), in favor of Spear USA Inc., formerly known as Spear USA, LLC, an Ohio Corporation (the "Grantor")

WHEREAS, pursuant to the terms and conditions of that certain Second Lien Intellectual Property Security Agreement dated June 2, 2008, by and among Grantor, Gardoc, Inc., and Security Trustee for itself, the Banks and the Hedging Banks, as defined therein (the "Security Agreement"), Grantor granted to Security Trustee a security interest in and to Grantor's right, title and interest in, to and under certain of Grantor's patents, including those set forth on Exhibit A attached hereto ("Patents");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 6, 2008 at Reel 021050, Frame 0686;

WHEREAS, Grantor and Security Trustee terminated the security interest in and to the Patents pursuant to that certain Deed of Release of Security, dated May 7, 2013, by the Security Trustee, Altima Global Special Situations Master Fund Limited, Altima Global Special Situations Master Fund Limited in favor of the Grantor (the "Deed of Release"); and

WHEREAS, Grantor and Security Trustee have agreed to execute this Release for recordation with the United States Patent and Trademark Office to evidence that the security interest in and to the Patents has been terminated pursuant to the Deed of Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Security Trustee hereby terminates, cancels and releases any and all security interests it has against the Patents as of May 7, 2013.

IN WITNESS WHEREOF, Security Trustee has caused this Release to be executed by its duly authorized representatives as of the date set forth above and the Security Trustee authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
