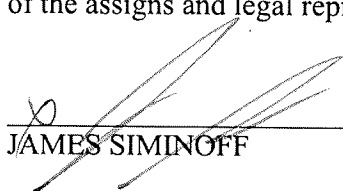
Illuminated Signal Device and Speed Detector for Audio/Video Recording and Communication Devices
