and the said Application in appropriate registries; and I hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said Improvements to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.


