GULLICKSEN BROTHERS, LLC, a California limited liability company (the "**Company**"), does hereby certify to the following facts relating to the conversion of the Company to Reavire, Inc., a Delaware corporation to be simultaneously formed with the filing of this Certificate of Conversion (the "**Conversion**"):

FIRST: The name of the Company is "Gullicksen Brothers, LLC". The Company's Articles of Organization were originally filed with the Secretary of State of the State of California on July 8, 2016. The Company is a limited liability company formed under the California Revised Uniform Limited Liability Company Act.

SECOND: The name of the corporation to which the Company will be converted is "Reavire, Inc."
