AND, WE HEREBY further covenant and agree that if necessary, the Assignee, its affiliates and its agents are hereby authorized to insert into the list of the countries, filing dates and serial numbers information about the countries, the filing dates and the serial numbers when known;

AND, WE HEREBY covenant that we have the full right to convey the interest assigned by this Assignment, and we have not executed and will not execute any agreement in conflict with this Assignment;

AND, WE HEREBY further covenant and agree that we will communicate with the Assignee, its successors and assigns, any facts known to us respecting these inventions, testify in any legal proceedings, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title to these inventions in said Assignee, its successors

or assigns, execute all divisional, continuation, reissue, and re-examination applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors and assigns, to obtain and enforce proper patent protection for these inventions in any jurisdiction of the Territory, it being understood that any expense incident to the performance of the obligations of the present paragraph shall be borne by the Assignee, its successors, and assigns.
