- c) the right to progress the Patent Applications and any other patent applications based on or claiming priority from the Patent Applications to patent grant in any one or more of Australia, Japan, Canada, Europe, China and USA and in any other country that the Assignee desires, such right to include all right to all divisions thereof and all letters patent, reissues, re-examinations and amendments thereof, to hold unto the Assignee absolutely.
