- all patents or design registrations which may be granted on or as a result thereof;
- any reissue or reissues of such patents; and
- all causes of action and rights to bring suit for past, present, and future infringement thereof and all claims for and rights to collect damages, profits, and all other remedies and relief in respect thereof, including other compensation in respect of pre-grant activities;

the same to be held and enjoyed by the Assignee, its successors, assigns, nominees, or legal representatives, to the full end of the term or terms for which such patents or design registrations respectively may be granted, reissued, or extended, as fully and entirely as the same would have been held and enjoyed by the Assignor(s), had this Assignment, sale, and transfer not been made.

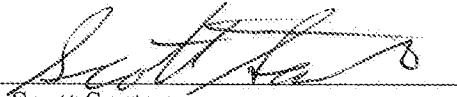

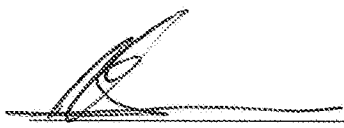

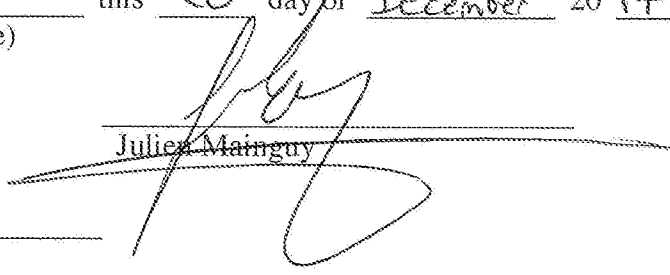
