1. In pursuance of this Assignment and in consideration of:
 - a) the sum of one pound sterling paid by the Assignee to the Assignor (the receipt and sufficiency of which is hereby acknowledged), the Assignor as beneficial joint owner hereby assigns unto the Assignee all the benefit of its share of The Patents and any patent application or like protection based thereupon (including the right to file divisional or continuation patent applications claiming priority therefrom or based thereon), the property right title and interest therein and all the rights, powers, liberties and immunities arising or to arise therefrom to the intent that the grant of a patent on The Patents or claiming priority therefrom shall be in the name of and shall vest in the Assignee TO HOLD unto the Assignee absolutely. The Assignee shall be free to deal in and/or with The Patents as it sees fit without recourse to the Assignor.

2. The Assignor will, at the expense of the Assignee, do all the acts and execute all documents which may be required in order to ensure that The Patents shall proceed in the name of the Assignee. The Assignor hereby warrants it is free to assign The Patents to the Assignee.
