**RELEASE OF SECURITY INTEREST
IN PATENT COLLATERAL**

This RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL, dated as of October 20, 2017 (this "Release"), is made by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH**, as agent for the Secured Parties (the "Agent"), in favor of **ADCO PRODUCTS, LLC**, a Delaware limited liability company, **ETERNABOND, LLC**, a Delaware limited liability company, **MILLENNIUM ADHESIVE PRODUCTS, LLC**, a Ohio limited liability company and **ROYAL ADHESIVES AND SEALANTS, LLC**, a Delaware limited liability company (individually, a "Grantor" and collectively, the "Grantors"), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Guarantee and Collateral Agreement and the Second Lien Patent Security Agreement.

WITNESSETH

WHEREAS, pursuant to the Second Lien Patent Security Agreement, dated as of June 24, 2015, and recorded with the U.S. Patent and Trademark Office June 24, 2015, at Reel/Frame Nos. 036018/0710, 036014/0611, 036018/0719, and 036014/0647 (the "Second Lien Patent Security Agreement"), Grantor granted to the Agent a security interest in and continuing lien on all of Grantor's right, title and interest in, to and under the Patent Collateral (as defined in the Second Lien Patent Security Agreement), including, without limitation, the United States patents set forth on Schedule A attached hereto (the "Released Registered Patents"); and

WHEREAS, Grantor has requested that the Agent release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Patent Collateral, including the Released Registered Patents; and

WHEREAS, the Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Patent Collateral, including the Released Registered Patents, and reassign any all rights, title and interest in the same to Grantor.

NOW, THEREFORE, the Agent, without recourse, representation or warranty of any kind or nature, and at Grantor's sole cost and expense, hereby terminates, cancels and releases its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Patent Collateral, including the Released Registered Patents, and any and right, title and interest of the Agent in such Patent Collateral and such Released Registered Patent, including all goodwill associated therewith, is hereby assigned, transferred, and conveyed to Grantor.

The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
