Assignor also assigns to Assignee all right, title and interest in and to the inventions disclosed in said Design Patent Property throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said Design Patent Property in its own name throughout the world, including all rights to publish cautionary notices reserving ownership of said inventions and all rights to register said Design Patent Property in appropriate registries; and Assignors further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee.

Assignors also assign unto Assignee all claims for damages by reason of infringement prior to the assignment date of the Design Patent Property throughout the world, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives.

Assignors also will communicate to Assignee any facts known to it respecting any improvements; and, at the expense of Assignee, will testify in any legal proceedings, sign all lawful papers, execute all provisional, divisional, continuation, continuation-in-part, reissue and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in Assignee and to aid Assignee to obtain and enforce proper protection for said Design Patent Property in all countries.

This Assignment may be executed in any number of counterparts, each of which, when executed and delivered, shall be deemed to be an original, and such counterparts taken together shall constitute one and the same Assignment.
