

ARTICLES OF CONVERSION**

Pursuant to §57D-9-32 of the General Statutes of North Carolina, the undersigned converting business entity does hereby submit these Articles of Conversion for the purpose of converting to a different business entity.

1. The name of the converting business entity is 410 Medical Innovation, LLC.
2. The converting business entity is a domestic limited liability company.
3. The mailing address of the converting entity prior to the conversion is 201 W. Main Street, Suite 207, Durham, NC 27701-3228.
4. The name of the surviving business entity is 410 Medical, Inc.
5. The surviving business entity is a foreign corporation.
6. The organization and internal affairs of the surviving business entity are governed by the laws of the state of Delaware.
7. The surviving business entity is not currently authorized to transact business in this State. The surviving entity consents to the service of process in any proceeding based on any cause of action arising in respect of the converting entity being made on the surviving entity by service on the Secretary of State. 8. A plan of conversion has been approved by the converting business entity as required by law.
