**AND WHEREAS**, pursuant to the Agreement and Counterpart Agreement, the Assignor sold, conveyed, assigned, and transferred to the Assignee all right, title and interest in, to and under, the patents and patent applications identified in Schedule A hereto (hereinafter, the "**Patent Assets**"), in the U.S.A. (hereinafter, the "**Territory**");

**AND WHEREAS**, in order to effect the recordal of the assignment and transfer of the Patent Assets in the Territory to the Assignee, the Assignor and Assignee hereby agree to sign this Confirmatory Assignment.

**NOW, THEREFORE**, in consideration of the foregoing and in consideration of the mutual promises, covenants, representations, warranties and agreements contained herein and in the Agreement, the Assignor hereby confirms having sold, conveyed, assigned, and transferred to the Assignee, its successors and assigns, effective as of February 27, 2017, its entire right, title, and interest in, to and under, the Patent Assets, inclusive of any continuations, divisionals, re-issuances or re-examinations thereof, all rights of priority in the Territory that are derived or arise from, or based on, such Patent Assets or corresponding foreign patent or industrial design rights that exist or arise in Canada and the rest of the world, and any and all patents that may issue on any of the foregoing in the U.S.A., and any and all right, title, interest, privileges, damages, settlements and proceeds under, relating to, or arising from, the Patent Assets, including, without limitation, any claim against third parties for past, present or future infringement or misappropriation of the Patent Assets, all of which or the same to be held and enjoyed by the Assignee for its own use and benefit, and for the use and benefit of its successors and assigns.
