# RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL

This RELEASE, dated as of October 31, 2017 (this "Release"), is made by KeyBank National Association, as administrative agent (in such capacity, the "Administrative Agent"), in favor of Oregon Iron Works, LLC, a Oregon limited liability company (the "Company"), as follows:

WHEREAS, in connection with the Security Agreement, the Company and Administrative Agent entered into the Collateral Assignment of Patents dated as of July 3, 2014 ("Collateral Assignment");

WHEREAS, pursuant to the Security Agreement and the Collateral Assignment, Company assigned, transferred, conveyed and granted to the Administrative Agent, for the benefit of the Secured Creditors (as defined in the Security Agreement), a security interest in, a general lien upon and/or a right of set-off against all right, title and interest of the Company in and to the following (collectively, the "Patent Collateral"): (i) all of the Patents issued by the United States Patent and Trademark Office (including, without limitation, those listed on Schedule A hereto), (ii) all applications for Patents to be issued by the United States Patent and Trademark Office (including, without limitation, those listed on Schedule A hereto); (iii) all Patents issued by any other country or any office, agency or other governmental authority thereof; (iv) all applications for Patents to be issued by any office, agency or other governmental authority referred to in clause (iii) above; (v) all registrations and recordings with respect to any of the foregoing; (vi) all reissues, continuations, continuations-in-part, extensions and divisions of any of the foregoing; (vii) all licenses and other agreements relating in whole or in part to any Patents, inventions, processes, production methods, proprietary information or know-how covered by any of the foregoing, including all rights to payments in respect thereof; (viii) all rights to sue for past, present or future infringements of any of the foregoing; (ix) all goodwill related to any of the foregoing; (x) to the extent not included above, all general intangibles (as such term is defined in the UCC) of the Company related to the foregoing; and (xi) all proceeds of any and all of the foregoing; and

WHEREAS, in connection with the Security Agreement, the Company granted the Agent a security interest in certain collateral pledged by the Company pursuant to the Collateral Assignment of Patents as further described therein, including, without limitation, the United States patents set forth on Schedule A attached hereto (collectively, the "Patent Collateral"); and

WHEREAS, the Company has requested that the Administrative Agent release its security interest in all right, title and interest of the Administrative Agent in and to the Patent Collateral.
