

WHEREAS, I believe that I am an original joint inventor of a claimed invention in the application;

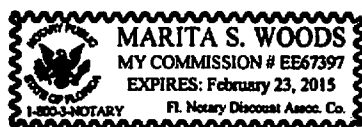



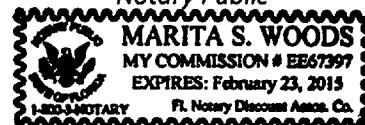
