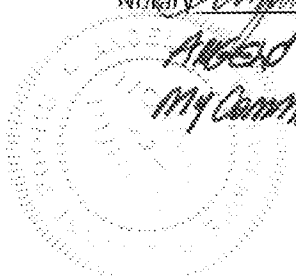

This termination includes the designing, sale, marketing, use of this method/device to multi store retail and wholesale accounts. In addition, with respects to any outstanding balance or debt owed for any cost accrued with respects to the agreement or patent application, there is none owed to either Joshua Mello, Fringe LLC or Ed Greene.
