BETWEEN

- (1) THE UNIVERSITY OF LEEDS, incorporated by Royal Charter (company number RC000658) whose address is Woodhouse Lane, Leeds, West Yorkshire LS2 9JT (**Assignor**).
- (2) XIROS LIMITED (Company No. 1664824) whose registered office is at Springfield House, Whitehouse Lane, Leeds, LS19 7UE (**Assignee**).

RECITALS

- (A) By an assignment ("the Assignment") dated 29 April 2013, the Assignor transferred certain patent rights to the Assignee.
- (B) The parties to this Assignment wish to confirm that as between the parties to this Assignment all right title and interest in and to the Patent Applications vest in the Assignee.

Operative Clauses

1. In this Agreement the following words shall have the following meanings:

"the Patent Applications" means the patent applications details of which are at Schedule 1

2. In consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which the Assignor confirms) the Assignor hereby assigns to the Assignee its entire right, title and interest in and to the Patent Applications including without limitation:
 - a. In respect of any and each of the Patent Applications;
 - i. The right to claim priority from and to prosecute and obtain grant of patent; and
 - ii. The right to file divisional applications based thereon and to prosecute and obtain grant of patent on each and any such divisional application;
 - b. In respect of each and any invention disclosed in the Patent Applications, the right to file an application, claim priority from such application, and prosecute and obtain grant of patent or similar protection in or in respect of any country or territory in the world;

- c. The right to extend to or register in or in respect of any country or territory in the world each and any of the Patent Applications, and to extend to or register in, or in respect of, any country or territory in the world any patent or like protection granted on any of such applications.
 - d. The absolute entitlement to any patents granted pursuant to any of the Patent Applications; and
 - e. The right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Patent Applications or any patents granted on any of the applications filed as aforesaid, whether occurring before or on or after the date of this assignment.
- 3. The Assignee hereby accepts the assignment at clause 2 of this Assignment.
 - 4. This Agreement shall be governed by and interpreted in accordance with the laws of England and the parties hereby submit to the exclusive jurisdiction of the English courts.


