In accordance with Section 253 of the Delaware General Corporation Law (the "DGCL"), PTC Inc., a Massachusetts corporation ("PTC"), does hereby certify:

FIRST: That PTC Inc. owns all of the issued and outstanding shares of Axeda Corporation ("Axeda").

SECOND: That the name, state of incorporation and date of incorporation of the constituent corporations of the merger are as follows:

THIRD: That the following resolution of the Board of Directors of PTC was adopted on September 18, 2014:

RESOLVED: That, from and after the time the entities named in the table below become direct subsidiaries of the Company (the "Acquired Entities"), the Company is authorized to merge each of the Acquired Entities with and into the Company and to assume all of such entity's liabilities and obligations.

FOURTH: That the surviving corporation of the merger shall be PTC.

FIFTH: The Articles of Organization of PTC will be the Articles of Organization of the surviving corporation.


SIXTH: PTC, as the surviving corporation, hereby:

- (i) Agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of Axeda, as well as for enforcement of any obligation of the surviving corporation arising from the merger, including any suit or other proceeding to enforce the right of any stockholders as determined in appraisal proceedings pursuant to § 262 of the DGCL;

- (ii) Irrevocably appoints the Secretary of State of the State of Delaware as its agent to accept service of process in any such suit or other proceedings; and
- (iii) Specifies that a copy of any such service of process shall be mailed by the Secretary of State to PTC Inc., Attention: General Counsel, 140 Kendrick Street, Needham, MA 02494.
