**SECOND LIEN PATENT RELEASE AND REASSIGNMENT**

THIS SECOND LIEN PATENT RELEASE AND REASSIGNMENT is made as of January 24, 2018, by WILMINGTON TRUST, NATIONAL ASSOCIATION (“Administrative Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Gehl Foods, LLC, (“Grantor”) and Administrative Agent were parties to that certain Second Lien Patent Security Agreement dated as of March 26, 2015 (the “Security Agreement”) pursuant to which the Grantor granted a security interest to Administrative Agent in certain Patents and Patent Collateral (as defined below) as security for certain obligations owing by Grantor to Administrative Agent, including the Patents set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Patent Division of the United States Patent and Patent Office on March 26, 2015, at Reel 035267, Frame 0281;

WHEREAS, Grantor has requested that Administrative Agent release its security interest in the Patents and Patent Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “Patent Collateral”):

(i) all of its Patents, including, without limitation, those referred to on Schedule 1 hereto;

(ii) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and

(iii) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Administrative Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent’s right, title and interest in and to the Patents and the Patent Collateral.
