

In furtherance of this instrument, ASSIGNOR hereby acknowledges that, from the effective date of July 15, 2014 and from that date forward, ASSIGNEE has succeeded to all right, title, interest and standing of ASSIGNOR to: (a) receive all rights and benefits pertaining to the Patent Rights; (b) institute and prosecute all suits and proceedings and take all actions that ASSIGNEE, in its sole discretion, may deem necessary or proper to collect, assert, or enforce any claim, right, or title of any kind in and to any and all the Patent Rights; and (c) defend and comprise any and all such actions, suits, or proceedings relating to such Patent Rights and do all other such acts and things in relation thereto as ASSIGNEE, in its sole discretion, deem advisable.
