For the same consideration, Assignor, by these presents does sell, assign, and transfer to Assignee the full, exclusive, and entire right, title and interest in and to any foreign and international applications related to and/or seeking benefit of U.S. Design Patent Application Serial Nos. 29/506,046; 29/566,440; and 29/601,518, which resulted in the Patents, and Related US Applications and in and to all inventions, designs and improvements thereon (herein collectively referred to as "Related Foreign Applications"), in and to any Letters Patent or Design Patent and similar protective rights granted on said Related Foreign Applications, and in and to the right to claim any applicable priority rights arising from or required for said Related Foreign Applications under the terms of any applicable conventions, treaties, statutes, or regulations, said Related Foreign Applications to be filed and issued in the name of Assignee or its designee, insofar as permitted by applicable law.






