PATENT ASSIGNMENT

THIS AGREEMENT is made between Mr Eden Graham Mansfield Stuart of 26 Rose Street, Tirau, 3410 New Zealand (the "Inventor")

AND

Stuart Design Ltd of 26 Rose Street, Tirau, 3410 New Zealand, a company incorporated in New Zealand (New Zealand limited company number 5038080) (the "Assignor")

AND

Risbridger Ltd. of 25 Trowers Way, Holmethorpe Industrial Estate, Redhill, Surrey, United Kingdom, RH1 2LH (the "Assignee").

AND WHEREAS Assignor is the first beneficial owner of the inventions particularised in Schedule 1 attached hereto by virtue of employing the Inventor at the time of devising the inventions described in the patent rights listed in Schedule 1.

Operative Provisions:



In pursuance of the said agreement and in consideration of the sum of £1 now paid by the Assignee to the Assignor, the Assignor HEREBY ASSIGNS to the Assignee all its interest in and to the inventions and all patent applications and patents granted thereon TOGETHER WITH his right to apply for and obtain patents or other similar forms of protection in respect of the inventions in the UK and in all other countries of the world TOGETHER WITH the right to make any new application or applications in respect of any part or parts of the subject matter of any application or specification filed in connection with the inventions in the UK and the right to claim priority under section 5 of the Patents Act 1977, and the right to claim priority under the Paris Convention (as amended) when making applications in countries or territories outside the UK TO HOLD the same unto the Assignee and its successors and assigns absolutely.
2. The Assignor on behalf of itself and its personal representatives covenants with the Assignee that it will at any time in the future promptly execute and do all such instruments or things as may be required by the Assignee to enable the Assignee to enjoy the full benefit of the rights confirmed and assigned by this Agreement including applying for and obtaining a patent or patents or other similar forms of protection in respect of the inventions in the UK and in all other countries of the world and vesting his rights in the same in the Assignee when obtained.
3. The Assignor hereby irrevocably appoints the Assignee as his Attorney in his name and on his behalf to execute and do any instrument or thing as may be required by the Assignee to enable the Assignee to enjoy the full benefit of the rights confirmed and assigned by this Agreement and in favour of any third party a certificate in

writing signed by any Director or Secretary of the Assignee that any instrument or act falls within such authority shall be conclusive evidence that such is the case.

WHEREBY Risbridger Ltd. as Assignee hereby declares to accept all rights, title and interest assigned in this Assignment.
