NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignors hereby assign and transfer to Assignee, its successors and assigns, all of Assignors' rights, title and interests, collectively and individually, worldwide, in, to and under: (i) the Patents, as well as all divisions, renewals and continuing patent applications (e.g., divisional applications, continuation applications and continuation-in-part applications) thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for inventions embodied by the Patents in any country or countries foreign to the United States, and all Letters Patent which may be granted for said inventions embodied by the Patents in any country or countries foreign to the United States and all extensions, renewals and reissues thereof and all rights of priority in any such country or countries based upon the filing of the Patents in the United States which are created by any law, treaty or international convention, as well as, worldwide, all patents and patent applications related to or claiming priority to the Patents, including all designs, industrial, model utility and utility patents and patent, (all of which shall be included in the Patents); (ii) all files and records relating to the prosecution, exploitation, and defense of any of the foregoing; and (iii) all rights to causes of action and remedies pertaining to the Patents, including without limitation the right to sue and recover for past, present or future infringement or violation of rights related to the foregoing, the right to secure registration of the Patents and of this Assignment, the right to initiate other proceedings before all government and administrative bodies with respect to the Patents.

AND Assignors hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on any such applications as aforesaid, to issue all

Letters Patent for said inventions to Assignee, its successors and assigns, in accordance with the terms of this instrument.

AND Assignors do hereby covenant that it has full right to convey the entire interest herein assigned, and that Assignor has not executed, and will not execute, any agreement in conflict herewith.

AND Assignors do further hereby covenant and agree that it will communicate to Assignee, its successors and assigns, any facts known to it respecting the Patents, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce any attendant rights in all countries.

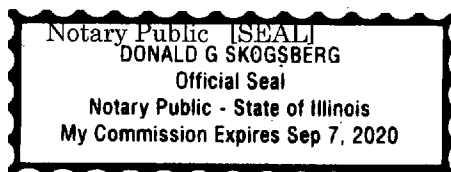

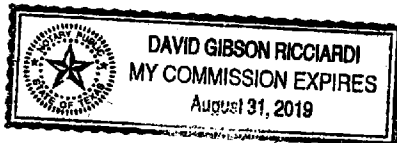
