successors, nominees, or assigns to secure full and complete protection for said INVENTION or that may be necessary to vest in said ASSIGNEE the complete title to the said INVENTION and patents hereby conveyed and to enable ASSIGNEE to record said title.

ASSIGNOR authorizes and requests the Commissioner of Patents and Trademarks of the United States and of all foreign countries to issue any Patent granted for said INVENTION, whether on an application for said INVENTION, said Patent Application, or on any subsequently filed provisional, non-provisional, divisional, continuation, continuation-in-part, reissue, reexamination, extension, renewal, or other application, to ASSIGNEE, its successors and assigns, as the ASSIGNEE of ASSIGNOR's entire interest in said INVENTION.
