PATENT ASSIGNMENT

3. **Counterparts.** This Assignment may be executed in counterpart, each of which shall constitute an original and both of which, when taken together, will constitute one agreement.

4. **No Modification; Conflicts.** This Assignment is subject in all respects to the terms and conditions of the PA. This Assignment does not in any way modify or expand any of the rights and obligations of the parties set forth in the PA, but is being delivered solely to evidence the transfer, sale, assignment and delivery of the Patents to Assignee. If any conflict exists between the terms of this Assignment and the PA, the terms of the PA shall govern and control.


