NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and sufficient consideration, the receipt of which is hereby acknowledged, Assignor, on behalf of itself and its Affiliates, has sold, assigned, transferred and set over, and by these presents does sell, assign, transfer and set over, unto Assignee, its successors, legal representatives and assigns, all of its right, title and interest in and to the Invention and Patent Applications, and in and to any and all divisions, and continuations of said Patent Applications and any and all letters patent in the United States and all foreign countries which may be granted therefor and thereon, and reissues, reexaminations and extensions of said letters patent, and all rights under the International Convention for the Protection of Industrial Property, and the use and benefit of its successors, legal representatives and assigns, to the full end of the term or terms for which letters patent may be granted and/or extended, and together with the right to all income, royalties or payments due or payable with respect thereto and the right to sue and recover for, and the right to profits or damages, due or accrued, arising out of or in connection with any and all past, present or future infringements or dilution of or damage to any of the foregoing.

AND for the same consideration, the Assignor hereby represents and warrants to Assignee, its successors, legal representatives and assigns, that, at the time of execution and

delivery of these presents, that Assignor has acquired, and is now the sole and lawful owner of, all the right, title and interest in and to the Invention and Patent Applications. **EXCEPT FOR THE FOREGOING, ASSIGNOR MAKES NO OTHER WARRANTY OR REPRESENTATION AS TO THE INVENTIONS AND PATENT APPLICATIONS, AND EXPLICITLY DISCLAIMS HEREIN ANY OTHER EXPRESS OR IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTIES OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AS TO THE PATENT APPLICATIONS AND INVENTION, INCLUDING THAT ANY PATENT RIGHTS WILL BE GRANTED BY ANY GOVERNMENT PATENT OFFICE AS TO THE SUBJECT SET FORTH IN THE PATENT APPLICATIONS OR TO THE INVENTION.**

AND for the same consideration, Assignor hereby covenants and agrees to and with Assignee, and its legal representatives, that Assignor will sign all papers and documents, take all lawful oaths or affirmations and do all acts reasonably necessary or required to be done for the procurement, and maintenance in any country of any letters patent and applications for letters patent for said Inventions (including, but not limited to, the Patent Applications), in connection with any proceedings or process, including, but not limited to, interference, divisional, continuation and continuation-in-part applications for letters patent, and reissue, reexamination and extension of letters patent, at Assignee's expense whenever counsel of Assignee, or its legal representatives, shall advise that such proceeding or process is lawful and desirable.

AND Assignor shall request the Commissioner of Patent and Trademarks to issue said letters patent of the United States to Assignee, as Assignee of said Inventions and the letters patent to be issued thereon, for the sole use and benefit of Assignee, its successors, legal representatives and assigns.

AND this Assignment and all matters relating to or arising under this Assignment shall be governed in all respects by the laws of the State of New York, without giving effect to principles of conflicts of law, and the State or Federal courts of competent jurisdiction in New

York County, State of New York shall have exclusive jurisdiction over any litigation arising out of or connected in any way with this Assignment.
