RELEASE PATENT SECURITY INTEREST

THIS RELEASE OF PATENT SECURITY INTEREST (this "Release") is made as of February 13, 2018 ("Effective Date") by Orix Growth Capital, LLC (the "Lender"), in favor of Practice Fusion, Inc., a Delaware corporation (the "Grantor"). All terms not herein defined, have the meanings set forth in the Loan Agreement or Security Agreement referenced below.

WHEREAS, Grantor and the Lender are parties to that certain Loan and Security Agreement dated as of October 7, 2016 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement") executed in order to secure the prompt and complete payment, observance and performance of all of the obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Loan Agreement, the Grantor was required to execute and deliver an Intellectual Property Security Agreement dated as of October 7, 2016 (the "Security Agreement") to the Lender for purposes of filing with the United States Patent and Trademark Office ("USPTO");

WHEREAS, pursuant to the Loan Agreement and Security Agreement, the Grantor granted to the Lender, among other collateral as set forth therein, a continuing security interest in all of the Grantor's right, title and interest, in, to and under the United States patents registrations and applications listed on the attached Schedule A (the "Patents");

WHEREAS, the Security Agreement was recorded in the USPTO on October 7, 2016 at Reel/Frame 039969/0106; and

WHEREAS, the Lender wishes to release its security interest in the Patents.


