## ASSIGNMENT

Title: FOOD PRODUCTS AND METHODS OF PREPARING THE SAME

This agreement ("Assignment") is by and among KURARAY CO., LTD., with offices at 1621, Sakazu, Kurashiki-Shi, Okayama, Japan 710-0801, ("Kuraray"), ICHIRO NAKANO, an employee of Kuraray having a mailing address of Kuraray HQ 1-1-3 Otemachi, Chiyodaku, Tokyo, Japan 100-8115, ("Mr. Nakano"), and MONOSOL, LLC, with offices at 707 E. 80th Place, Suite 301, Merrillville, Indiana, USA 46410 ("MonoSol").

For good and valuable consideration, the receipt and sufficiency of which are hereby agreed, the parties hereby agree as follows:

1. Mr. Nakano agrees to assign and hereby assigns to Kuraray the entire right, title, and interest in and to the inventions disclosed in the application listed above, all rights in any and all other applications anywhere in the world that Mr. Nakano may file and/or be named as an inventor of, solely or jointly, on said inventions, all rights in any and all patents that may be obtained on any of said applications, all rights in any and all reissues, reexaminations, supplemental examinations, inter partes reviews, oppositions, post-grant reviews, supplementary protection certificates, and/or extensions thereof, the right to bring suit, the right to claim and retain all damages and/or seek other remedies for the past, present, and future infringement of any of the foregoing, and the right of priority including, without limitation, the right to claim priority benefit of or to the application listed above ("Assigned Rights").
2. Kuraray agrees to assign and hereby assigns to MonoSol and its successors and assigns ("Assignee") the entire right, title, and interest in and to the Assigned Rights.
3. The Commissioner for Patents in the United States and similar authorities outside the United States will issue patents claiming the Assigned Rights to and in the name designated by Assignee.
4. That the application listed above is or was made or authorized to be made by Mr. Nakano and Kuraray. Mr. Nakano believes himself to be the original inventor of the inventions in the application listed above. Mr. Nakano acknowledges that any willful false statement made by him in this paragraph is punishable under 18 U.S.C. §1001 by fine or imprisonment of not more than five years, or both.
5. Except in favor of Assignee, Kuraray warrants that: (i) it is the owner of all its rights, title and interests in the Assigned Rights and has the right to make this unconditional and irrevocable assignment to Assignee without obtaining any approval or permission of a third party; and (ii) there are no outstanding encumbrances, liens, prior assignments, licenses, or other obligations or restrictions on the Assigned Rights.
6. Upon the request of Assignee and at no expense to Mr. Nakano and Kuraray, Mr. Nakano and Kuraray hereby agree to execute any and all applications, certificates, oaths or affidavits relating to the Assigned Rights that Assignee may deem necessary or expedient, and to cooperate to the best of their ability with Assignee and perform any and all affirmative acts requested by Assignee to prepare, file, prosecute, maintain, defend,

enforce, and vest in Assignee the rights, title, and interests in the Assigned Rights including, without limitation, preparing and executing statements and giving and producing evidence in support thereof, whereby the Assigned Rights will be held and enjoyed by Assignee to the full end of the term permitted by law as fully and entirely as the same would have been held and enjoyed by Kuraray and/or Mr. Nakano if this Assignment had not been made.
