Assignor represents that (i) the Assignor is the legal owner of all right, title, and interest in and to the Patents, (ii) the Assignor has the right to assign the Patents, (iii) the Assignor has not licensed or assigned the Patents to another party, and that there are no pending legal proceedings involving the Patents; (iv) the Assignor is not aware of any third party who has asserted a claim of any ownership right, title or interest in the Patents or the underlying inventions; and (v) the Assignor is not a party to any prior agreement, nor has it made any informal commitment or reached any understanding with any other person or legal entity relating to the Patents which would be breached or otherwise violated by the foregoing assignment.

This Assignment shall be binding upon the parties, their successors and/or assigns, and all other acting by, through, with, or under their direction and all those in privity therewith.

Assignor agrees to cooperate with Assignee to take any further action and execute any documents required to affect the purposes of this Assignment and the intent of the parties hereto.
