ASSIGNOR further hereby authorizes and requests the Commissioner of Patents and Trademarks or similar appropriate authority to issue all patents for said invention, or patents resulting therefrom, insofar as ASSIGNOR'S interest is concerned, to the said ASSIGNEE of ASSIGNOR'S entire right, title and interest, and to record and register this Assignment to reflect ASSIGNEE'S ownership.

ASSIGNOR further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.


