AGREEMENT AND ASSIGNMENT REGARDING
PATENT APPLICATION AND PATENT(S)

This Agreement is entered into and effective for all purposes this 22 day of February, 2018, by and between Independence Fuel Systems L.L.C. ("IFS") and Bradley H. Thiessen ("Thiessen").

RECITALS:

WHEREAS, IFS is engaged in the business of the construction and operation of Compressed Natural Gas (CNG) refueling stations (the "CNG Stations"); and

WHEREAS, Thiessen is a Member of IFS; and

WHEREAS, Thiessen has assisted IFS in the design and construction of its CNG Stations and in the course of same has applied for a patent for the invention known as the "Intelligent CNG Fuel Distributor" under U.S. Patent and Trademark Office Application Number 14/499,080 (the "Patent Application"); and

WHEREAS, prior to the filing of the Patent Application, IFS agreed to fund and/or reimburse Thiessen for all costs, including attorney fees, application filing fees and out of pocket costs, incurred in connection with the effort to obtain the patent for the Intelligent CNG Fuel Distributor and Thiessen agreed to assign to IFS seventy-five percent (75%) of the Patent Application and seventy-five percent (75%) of all rights related to the Patent Application and any patent(s) issued pursuant thereto;

NOW, THEREFORE, the premises having been considered and with acknowledgment of the mutual promises and of other good and valuable consideration herein contained, the undersigned, intending to be legally bound, do hereby confirm their prior agreement and do hereby agree as follows:


1. IFS shall reimburse Thiessen all out of pocket expenses incurred by him in connection with the application process;
2. IFS shall pay all remaining attorney fees due to Baker & McKenzie LLP, it being recognized that IFS has paid (or reimbursed Thiessen) all attorney fees previously paid to Baker & McKenzie;
3. In consideration of 1 and 2 above, Thiessen hereby assigns to IFS an undivided 75% interest in and to all rights related to the design of the Intelligent CNG Fuel Distributor, together with a like interest in and to the Patent Application and any patent(s) issued pursuant thereto;
4. Upon issuance of any formal patent(s), Thiessen shall execute any and all documents necessary to further vest IFS with 75% of all patent(s) and patented rights.

This Agreement shall be governed by the laws of the State of Texas.

This agreement shall be binding upon the parties hereto and their respective successors and assigns.
