Such assignment shall be effective as of January 17, 2018.

There are no actions (including any oppositions, interferences or re-examinations) settled, pending or, to the Assignor's knowledge, threatened: (i) alleging any infringement, misappropriation, dilution or violation of the intellectual property of any third party by the Assignor; (ii) challenging the validity, enforceability, registrability or ownership of any Assignor patent; or (iii) by the Assignor or any third party alleging any infringement, misappropriation, dilution. The Assignor is not subject to any outstanding or, to the Assignor's knowledge, threatened Governmental Authority (including any motion or petition therefor) that does or would restrict or impair the use of any of Assignor's patents.

Each Party, upon the reasonable request of the other Party, agrees to perform all further acts and execute, acknowledge, and deliver any documents that may be reasonably necessary, appropriate, or desirable to carry out the provisions of this Agreement.

This Assignment is deemed to be executed and delivered within the State of California, and it is the intention of the parties that it shall be construed, interpreted and applied in accordance with the laws of the State of California without regard to its conflicts of law principles.

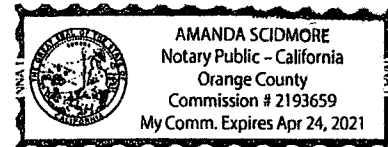

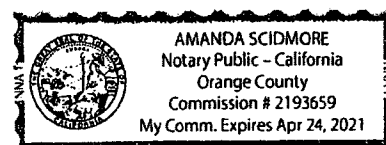
