WHEREAS:

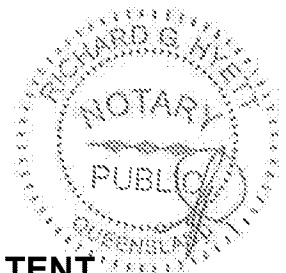


