The assignment of the Assigned Patent includes all of Assignor's documents related to the conception, diligence and reduction to practice of the inventions disclosed in the Assigned Patent and all domestic and international patent filing documents.

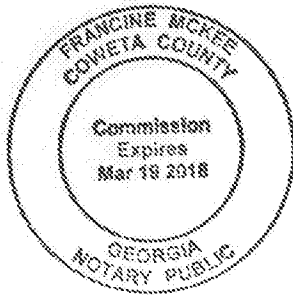


