ASSIGNMENT

THIS ASSIGNMENT is made the 24 day of May 2017

BETWEEN

1. Jérôme SOCHELEAU, a French citizen of 14, rue des petits champs, 78450 Vernouillet, France, and
2. Olivier VANNEUVILLE, a French citizen of 23 rue Roland Garros, 91220 Brétigny-sur-Orge, France ("the Inventors")

AND

3. Goodrich Actuation Systems SAS, a French Corporation of 106 rue Fourny, 78530 Buc, France ("GOODRICH")

WHEREAS

2. GOODRICH shall have the right to file applications for and/or be granted patents, utility models, registered designs, design patents, and any other intellectual property rights in its own name or in the names of the Inventors or in such other name or names as GOODRICH may desire and the Inventors acknowledge that if any such applications are filed or rights granted in the name of the Inventors the same shall be held in trust by the Inventors for GOODRICH and shall at the request of GOODRICH be transferred from the Inventors to GOODRICH for no further consideration.

3. The Inventors hereby covenant with GOODRICH if and when required by GOODRICH to sign execute and do all such further documents, acts or things as may be necessary or desirable to enable GOODRICH to procure and enjoy the full and exclusive benefit of the Invention(s) and of all rights therein, including patents, design patents, registered designs, utility models or other intellectual property rights in any country of the world including if required the execution of further assignments by way of confirmation of this assignment and the execution of documents in connection with applications for patents, utility models, registered designs, design patents or any other intellectual property rights in the Inventor's own names in respect of the United States of America or any other country.


