
ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment;

documents and render such assistance which in the judgment of ASSIGNOR is necessary to vest in it and protect the legal title sought to be assigned.
