AND said Assignor HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any foreign country whose duty it is to issue patents on applications as described above, to issue all Letters Patent for this invention to Assignee, its successors and assigns, in accordance with the terms of this Assignment;

AND said Assignor HEREBY covenants that the Assignor has the full right to convey the interest assigned by this Assignment, and the Assignor has not executed and will not execute any assignment, sale, license, agreement, or encumbrance in conflict with this Assignment;

AND said Assignor HEREBY further covenants and agrees, for the Assignor and the Assignor's legal representatives, that the Assignor will, without further consideration, communicate with Assignee, its successors and assigns, any facts known to them respecting this invention; assist the Assignee in the prosecution of the patent application identified above; assist in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; testify in any interference, litigation, or other legal proceeding; sign all lawful papers when called upon to do so; execute and deliver any and all papers that may be necessary or desirable to perfect the title to this invention in said Assignee, its successors or assigns; execute all divisional, continuation, and reissue applications; make all rightful oaths and generally do everything possible to aid Assignee, to obtain and enforce proper patent protection for this invention in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by the Assignee; and hereby instruct, and further covenants and agrees to bind my heirs, legal representatives, and assigns, to do same, without compensation, but at the expense of Assignee or its representatives.

AND said Assignor HEREBY consents that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of **AT&T INTELLECTUAL PROPERTY I, L.P.** to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.
