## ASSIGNMENT AND CONFIRMATORY PATENT ASSIGNMENT

This ASSIGNMENT AND CONFIRMATORY PATENT ASSIGNMENT (the "Assignment") is entered into as of and is effective as of the 21st day of February, 2018 (the "Effective Date") by and among Thomas Lewis, an individual having an address at PO Box 64, Bruce Rock, Western Australia, Australia 6418 ("LEWIS"), Matthew Barrett-Lennard, an individual having an address at PO Box 64, Bruce Rock, Western Australia, Australia 6418 ("BARRETT-LENNARD"), and TECFARM PTY LTD, an Australia limited company having an address at PO Box 64, Bruce Rock, Western Australia, Australia 6418 ("TECFARM"). LEWIS, BARRETT-LENNARD, and TECFARM may be individually referred to herein as a "Party" or collectively referred to herein as the "Parties."

For good and valuable consideration including the sum of five U.S. dollars (US\$5.00), the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Assignment of Patents and/or Patent Applications. LEWIS and BARRETT-LENNARD hereby irrevocably assign, transfer, and convey to TECFARM all of their respective right, title, and interest in, to, and under the inventions and patent applications and/or patents set forth below:

U.S. Patent Application Serial No. 15/755,952, filed 27 February 2018,

and hereby incorporated by reference herein, including, without limitation, (i) all inventions and improvements disclosed therein, (ii) all letters patent or similar legal protection granted therefor in the United States, its territorial possessions, and in all foreign countries, unions, or regions, (iii) all continuations, divisions, continuations-in-part, substitutions, reissues, renewals, substitutes, and extensions thereof and applications therefor, in the United States and its territorial possessions and in all foreign countries, unions, or regions, (iv) any and all patents and patent applications that claim priority to any of the foregoing, and (v) all rights to enforce including, but not limited to, the right to sue and collect damages for any past or future infringements throughout the world (the "Assigned Patents"). This assignment may have multiple effective dates, such as being a confirmatory assignment for any filings that predate the Execution Date, so to confirm the full assignment of rights from LEWIS and BARRETT-LENNARD to TECFARM in the Assigned Patents. Upon execution of the present Assignment, the full assignment of rights from LEWIS and BARRETT-LENNARD to TECFARM in the Assigned Patents is confirmed as of at least the filing dates for each of the Assigned Patents.

2. Filing and Recording Instruments of Transfer. TECFARM, at its sole discretion, shall make all filings with the requisite intellectual property offices in order to confirm, effectuate, or record this Assignment of the Assigned Patents to TECFARM granted herein. TECFARM shall be responsible to file and record any and all documents of conveyance as may be necessary to vest in TECFARM, as a matter of public record, all of the Assigned Patents.

3. Appointment. LEWIS and BARRETT-LENNARD hereby constitute and appoint TECFARM, and its successors and assigns, the true and lawful attorney or attorneys in fact of LEWIS and BARRETT-LENNARD, with the full power of substitution, for it and in its name and stead or otherwise, to institute and prosecute from time to time, any proceedings at law, in equity, or otherwise, that TECFARM, or its successors or assigns, may reasonably deem proper in order to assert or enforce any claim, right, or title of any kind in and to the Assigned Patents, and to defend






