ASSIGNMENT OF PATENT AND INTELLECTUAL PROPERTY RIGHTS

Whereas I, Theodore R. Further, as Assignor is or may be the owner, in full or in part, of tangible, intangible, proprietary and intellectual property rights, including though expressly without limitation, copyrights and patents, whether or not recorded or registered, in the concepts and technologies used, incorporated, or otherwise related to products which have prior to the date hereof been made available for sale by or through Assignee, including though expressly without limitation products related to Dust Director and/or Dustless Inc., and further including inventions, discoveries, improvements, writings, diagrams, sketches, specifications, computer files, data, or compilations arising from, related to or owned in whole or in part by Assignor, Dustless Inc. and/or Dust Director, and of ownership of any stock, membership interest or other ownership interest of Assignor in Dustless, Inc., Dust Director and/or Industrial Contractors Supply Inc. (all the aforesaid collectively being the "Property Rights"), and Assignee desires to acquire the ownership of all rights and interests in the Property Rights;

Therefore, in further consideration of the above, Assignor hereby assigns to Assignee all right, title and interest in the Property Rights, including though expressly without limitation of the complete assignment described above:

(1) all copyrights, trade secrets, trademarks and associated good will and all patents which have or may in the future be granted on the Property Rights, and all drawings, diagrams, specifications, products, computer aided drafting (CAD) files of any nature, samples, models, and/or prototypes, inventions, discoveries, improvements, writings, diagrams, sketches, specifications, computer files, data, or compilations arising from, related to or owned by Assignor, Dustless Inc. and/or Dust Director, and ownership of any stock, membership interest or other ownership interest of Assignor in Dustless, Inc., Dust Director and/or Industrial Contractors Supply Inc., along with any other right or interest related to the aforesaid; and


(2) all URL rights, access, accounts, usernames, security devices (physical or electronic) and all other interests whatsoever, including domain, domain registration, website files, website hosting services, email services and any other matter related to the URL, in www.dustless-inc.com, www.dustdirector.com, www.icscompany.net, and any other internet domain to which Assignor has rights or access which is related to the Property Rights.

Assignor warrants that such rights have not been previously licensed, pledged, transferred, sold, assigned, or encumbered. Assignor agrees to cooperate with Assignee and to execute and deliver all papers, authorizations, instruments and assignments as may be necessary to vest all right, title and interest in and to the Property Rights in Assignor.

The title of this document shall in no way be construed to limit the scope of the terms of the above assignment.






