ASSIGNMENT

- (1) the territory of the United States of America, including all continuation, divisional, continuation-in-part and reissue of THE INVENTIONS, and all applications for extension filed or to be filed for THE INVENTIONS,
- (2) any foreign country, and
- (3) the Patent Cooperation Treaty.

West Interactive Services Corporation also assigns any right, title or interest in and to THE INVENTIONS, which has not already been transferred, to West Corporation.

West Interactive Services Corporation warrants that no assignment has been made of THE INVENTIONS, any portion thereof, or any patent, patent application, Invention Registration, or Utility Model therefrom to a party other than West Corporation, and West Interactive Services Corporation is under no obligation to make any assignment of THE INVENTIONS, any portion thereof, or any patent, patent application, Invention Registration, or Utility Model therefrom to any other party.



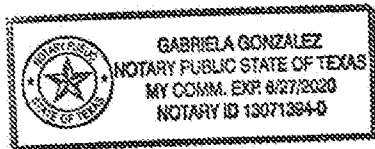
