(3) in and to all patent applications on said invention now or hereafter filed in countries foreign to the United States of America, including patent applications filed under the Patent Cooperation Treaty, the European Patent Convention or any other

international treaty, and including the right to claim priority of said U.S. provisional patent application and in and to any and all patents granted on said applications to the full end of the terms for which said patents may be granted.

I hereby agree that I will, upon demand of Assignee, its successors or assigns, and without further consideration to me, execute any and all papers that may be necessary, or deemed by Assignee, its successors or assigns, to be necessary, to a complete fulfillment of the intent and purposes of this Assignment, it being understood that any expense incident to the execution of such papers shall be paid by Assignee, its successors and assigns, and not by me.

If the right applicable to any such patent application allows an assignee to be the applicant of the patent application, Robert Bosch GmbH shall have the right to be identified as applicant of the patent application and the right to claim priority of said U.S. utility patent application. This limited right granted to Robert Bosch GmbH with respect to any patent application or granted patent shall expire upon the first-occurring of (i) assignment to a third party of any of the above-mentioned rights of Assignee, or (ii) with respect to any particular patent, issue of such patent, and shall be subsequently part of the assignable rights of Assignee.
