AND for the same consideration, Assignor hereby covenants and agrees to and with Assignee, their successors, legal representatives and assigns, that Assignor will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of said Letters Patents, and any and all Letters Patents and applications for Letters Patent for said inventions, whenever counsel(s) of Assignee, or counsel(s) of their successors, legal representatives and assigns, shall advise: that any proceeding in connection with said inventions, said Letters Patents, or said applications for Letters Patent, or any proceeding in connection with any and all Letters Patents or applications for Letters Patent for said inventions in the United States, including but not limited to interference proceedings, is lawful and desirable; or that any division or continuation of any application for Letters Patent, or any reissue, reexamination or extension of any Letters Patent, to be obtained thereon, is lawful and desirable.

AND Assignor hereby requests the Commissioner of Patent and Trademarks to issue said Letters Patent of the United States to Assignee, as Assignee of said invention and the Letters Patent to be issued thereon, for the sole use and benefit of Assignee, their successors, legal representatives and assigns.



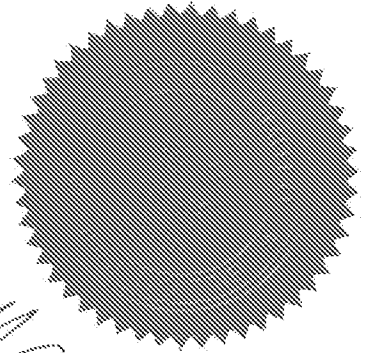


