ASSIGNMENT

Recitals



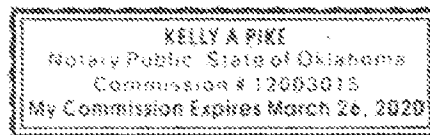


