**ASSIGNMENT OF INVENTION**

WHEREAS, I, **William Carrière**, 206 Braebrook Street, Pointe-Claire, Quebec, H9R 1V5, Canada, have invented certain new and ornamental improvements in a **SWIMMING POOL BRUSH** for which a design patent application for Letters Patent in the United States is being filed.

AND WHEREAS, **CPA POOL PRODUCTS, INC.**, 31, Boul. De La Seigneurie Est, Bureau 206 Blainville, Quebec, Canada J7C 4G6 (the "ASSIGNEE"), is desirous of acquiring all interest in said improvements, said applications, and in any Letters Patent which may be granted therefor.

NOW THIS INDENTURE WITNESSETH, that for the sum of one dollar and other valuable consideration to me in hand paid, the receipt of which is hereby acknowledged, I hereby assign, sell, and transfer unto the ASSIGNEE my entire right, title, and interest in said improvements, said application, and all national phase, divisional, continuing, substitute, renewal, reissue, and all other applications for Letters Patent which have been or shall be filed in the United States and all foreign countries on any of said improvements; and in and to all original and reissued patents which have been or shall be issued in the United States and all foreign countries on said improvements; and in and to any and all priority rights, rights under the International Convention For The Protection Of Industrial Property, rights under the Patent Cooperation Treaty, and other benefits accruing or to accrue to me with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said ASSIGNEE as the assignee of my whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for patents, for filing subdivisions of said applications for patents, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid improvements, as the assignee thereof shall hereafter require and prepare at its own expense.
