## ASSIGNMENT

The undersigned inventor(s) (hereinafter "Assignor") of the residence(s) indicated below has invented a **Method and System Using Intelligent Agents for Dynamic Integration of Buy-Side Procurement Systems with Non-Resident, Web-Enabled, Distributed, Remote, Multi-Format Catalog Sources** (hereinafter "Invention"). Preferred embodiments of the Invention are disclosed in a United States Provisional Patent Application filed on or near even date herewith under the same title (hereinafter "Application").

Vinimaya, Inc., a Delaware corporation having a principal place of business at 155 White Plains Road, Suite 203, Tarrytown, NY 10591, and its successors, assigns, and legal representatives (hereinafter "Vinimaya") desires to secure the entire right, title and interest in and to the Invention.

For good and valuable consideration, the receipt of which is acknowledged, Assignor hereby:

1. Sells, assigns and transfers to Vinimaya the entire right, title and interest in and to the Invention, the Application, any other patent applications based in whole or in part upon the Invention for any country (including divisional, renewal, substitute, continuation, and continuation-in-part applications), and all patents which may be granted thereon (including all reissues, reexaminations, and extensions thereof);
2. Authorizes Vinimaya to file patent applications on the Invention in any country in the name of Vinimaya, or otherwise as Vinimaya may deem advisable;
3. Authorizes and requests the United States Commissioner of Patents and Trademarks, and such patent office officials in foreign countries as are duly authorized by their laws to issue patents, to issue any patents on the Invention to Vinimaya as the owner of the entire right, title, and interest therein or otherwise as Vinimaya may direct;
4. Agrees, without expense to Assignor but without further consideration, to carry out in good faith the intent and purpose of this Assignment by executing all divisional, renewal, substitute, continuation, continuation-in-part, reissue, and all other patent applications based on the Invention; executing all rightful oaths, assignments, powers of attorney and other papers; communicating to Vinimaya all facts known to Assignor relating to the Invention and the history thereof; and generally, doing everything reasonably possible which Vinimaya shall consider desirable for aiding in securing, maintaining, and enforcing proper protection for the Invention and for vesting title in Vinimaya to the Invention and all patent applications and patents based on the Invention;

5. Covenants that Assignor has the full right to convey to Vinimaya the entire interest to the Invention, and that Assignor has not executed, and will not execute, any agreement in conflict herewith;

6. Agrees to transfer a like interest upon request of Vinimaya, and without further remuneration, in and to any improvements growing out of or relating to the Invention or any patent applications or patents based thereon;

7. Authorizes Vinimaya to insert in this Assignment the serial number and filing date of the Application or any other information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this Assignment;

8. Covenants that this Assignment shall be binding upon Assignor's heirs and legal representatives.
