PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT (hereinafter "Assignment"), effective as of December 29, 2017 ("Effective Date") is by and between Michael L. McCormick, a Texas resident having an address of 6002 Hudson Bend Road, Austin, TX 78734 (hereinafter, "Assignor") and Wilson's Gun Shop, Inc., an Arkansas corporation having a business address of 2452 Co Road 719, Berryville, Arkansas 72616 (hereinafter "Assignee").

RECITALS

WHEREAS, Assignor is the owner of all right, title and interest in and to the patents and patent applications listed in **SCHEDULE A** attached hereto, and corresponding inventions disclosed therein (collectively, the "Patents");

WHEREAS, Assignor and Assignee are parties to that certain Membership Interest and IP Purchase Agreement dated as of December 29, 2017 (hereinafter, "Agreement"), pursuant to which, *inter alia*, Assignor agreed to sell, assign and transfer all of Assignor's right, title and interest in and to the Patents; and

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire, all of Assignor's rights, title and interest in and to the Patents.

NOW, THEREFORE, in consideration of the foregoing premises, and for other good and valuable consideration, the receipt of which is hereby acknowledged:

1. **ASSIGNMENT.** Assignor hereby sells, assigns, and transfers to Assignee, all of Assignor's worldwide right, title and interest in and to the Patents, including all divisions, reissues, reexaminations, continuations, improvements, renewals and extensions thereof, and all patents or similar legal protection issuing thereon, together with the right to sue for past, present, and future infringements thereof, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

2. **FURTHER ASSURANCES.** Assignor agrees to execute all papers and to perform such other proper acts as Assignee may deem necessary, at Assignee's expense, to secure for Assignee the rights herein assigned including but not limited to any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title, and interests in Assignee, its successors, assigns, and legal representatives. Assignor hereby authorizes and requests the applicable domestic and foreign patent offices applicable to the Patents to transfer the Patents to Assignee.

3. **RECORDAL.** Assignor agrees to execute all instruments and to perform all acts which are necessary to record this Assignment.

4. **Entire Agreement.** This Assignment is subject to all of the representations, warranties, covenants and indemnities relating to the Purchased IP set forth in the Agreement, all of which are incorporated herein by reference. In the event of any conflict or inconsistency between the terms of this Assignment and the terms of the Agreement, the terms of the Agreement shall prevail.

5. **Binding Assignment.** This Assignment shall inure to the benefit of and be binding upon the parties hereto and their respective affiliates, successors and permitted assigns. Nothing in this Assignment, express or implied, is intended to confer upon any Party other than Assignor, Assignee or their respective affiliates, successors and permitted assigns, any rights or remedies under or by reason of this Assignment.

6. **Governing Law.** This Assignment shall be governed by and construed in accordance with the laws of the State of Texas, without regard to its principles of conflict of laws. The Parties agree that all actions or proceedings in any way, manner or respect, arising out of or from or related to this Agreement shall be litigated exclusively in federal or state courts having situs in Travis County, Texas. Each Party hereby consents and submits to the jurisdiction of any local, state or federal court located within said county and state and hereby waives any rights it may have to transfer or change the venue of any such litigation.

7. **Severability.** If any provision of this Assignment shall be deemed invalid or unenforceable by any court of competent jurisdiction, then such portion shall be deemed severed, and the remainder thereof shall be enforceable in accordance with its terms.

8. **Defined Terms.** All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Agreement.

9. **Counterparts.** This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same agreement.

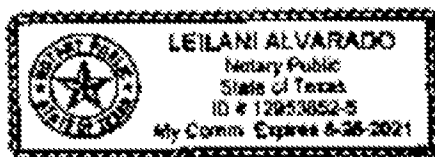

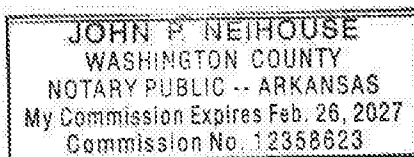
